Open Fishing Area

Quillayute River from mouth upstream to confluence of Murphy Ck above Bogachiel bridge on Hwy 110.

Opening /Closing Periods: 11/23/2020 through 1/20/2021

Opens at 7 AM Closes at 3PM on specified opening/closing days for each week.

Opening /Closing Periods: 1/25/2021 through 3/16/2021

Opens at 7 AM Closes at 6PM on specified opening/closing days for each week.

Gear Restrictions

No mesh size restrictions. One net only, set or drift per fisherman.


There are no assigned grounds from the mouth of the Bogachiel river to 100 meters above the LaPush Highway 110 bridge.


The upper area in the Bogachiel river is a first come first serve tribal commercial fishing area.

Outside anchors below boat basin must be pulled out when fishery is closed.

Note

- 1.) From Harbor Entrance to the mouth of the Quillayute River both sides, reflective tape or lighted device must be attached to the end of the net closest to the Navigational Channel.
- 2.) Schedule may be modified for conservation or other management requirements. Schedule adjustments or closures will be posted.
- 3.) This regulation supersedes all prior regulations and may be modified according to Quileute Tribe fish ordinance for management requirements.
