### Open Fishing Area

Quillayute River, from mouth upstream to confluence of Bogachiel and Sol Duc Rivers.

Starting Week 48: Quillayute River, from mouth upstream to confluence of Murphy Ck above Bogachiel bridge on Hwy 110

### Opening /Closing Periods for 8/29/2022 through 11/8/2022

**Opens at 6 AM** on specified day of the week

**Closes at 6 PM** on specified day of the week

### Opening /Closing Periods for 11/14/2022 through 12/9/2022

**Opens at 7 AM** on specified day of the week

**Closes at 3 PM** on specified day of the week

### Gear Restrictions

One net only, set or drift, per boat

Weeks 36 - 47: If Sol Duc stage height falls below 15.30 - 7 3/4" minimum monofilament mesh, 25ftm max net length, set net only

Note: These flow initiated restrictions can be activated and lifted within the same statistical week.

### Notes:

- 1.) From Harbor Entrance to the mouth of the Quillayute River both sides, reflective tape or lighted device must be attached to the end of the net closest to the Navigational Channel.
- 2.) Schedule may be modified for conservation or other management requirements
- 3.) Schedule adjustments or closures will be posted.
- 4.) Weeks 48-50 may be subject to change at a later date.
- 5.) All other regulations as per Quileute Tribal Fish Ordinances 2019-A-40
