POSITION SUMMARY: Manages all food ordering, preparation, delivery, and cleaning of food service to students in the early childhood center. Maintains records, ordering, and reporting to USDA/CACFP. Orders food and supplies and maintains professional relationships with vendors, families, and staff.

ESSENTIAL DUTIES AND RESPONSIBILITIES INCLUDE THE FOLLOWING:

- Prepare meals and snacks for chi? cho otsk ati children using USDA, Head Start, and Child Care guidelines
- Maintains inventory of food, supplies, and equipment
- Maintains equipment in good working order
- Plans menus with the assistance of the Nutritionist and Program Managers
- Type and provide the menu to Head Start and Child Care parents monthly
- Cleans worksite
- Prepares food for field trips and other school events
- Assists setting up classes for mealtimes
- Attends nutritional training and other classes as needed
- Must provide training to Head Start staff as per USDA guidelines
- Works with teaching staff to provide nutritional activities within the classroom
- Works with Nutritionist to provide appropriate meal service to children with allergies or other special dietary needs
- Must be willing to help in the classroom as needed
- Completes USDA contract and monthly meal counts
- Submits monthly meal counts and other data to OSPI as needed
- Works with the parents to allow input into menus and nutritional activities
- Orders, dates and stocks all food for early childhood programs
- Must be willing to prepare meals from scratch
- Must be willing to work as a positive team member
- Complete other duties as assigned
