Open Fishing Area

Quillayute River from mouth upstream to confluence of Murphy Ck above Bogachiel bridge on Hwy 110.

Opening /Closing Periods: 11/27/2023 through 1/25/2024

Opens at 7 AM Closes at 3 PM on specified opening/closing days for each week.

Opening /Closing Periods: 1/29/2024 through 3/20/2024

Opens at 7 AM Closes at 6 PM on specified opening/closing days for each week.

Gear Restrictions

Weeks 51 - 2: Two nets allowed (1 set and 1 drift) per boat

Weeks 3-12: One net only, set or drift per fisher.

No mesh size restrictions

There are no assigned grounds from the mouth of the Bogachiel river to Murphy Ck above the Bogachiel bridge on Hwy 110.

The upper area in the Bogachiel river is a first come first serve tribal commercial fishing area.

Note

- 1.) From Harbor Entrance to the mouth of the Quillayute River both sides, reflective tape or lighted device must be attached to the end of the net closest to the Navigational Channel.
- 2.) Schedule may be modified for conservation or other management requirements. Schedule adjustments or closures will be posted.
- 3.) This regulation supersedes all prior regulations and may be modified according to Quileute Tribe fish ordinance for management requirements.
- 4.) All other regulations as per Quileute Tribal Fish Ordinances 2019-A-40
