THIS MATTER having come before the Court *sua sponte* this 18th day of November, 2022 to set forth court dates and dockets, and the Court being fully informed finds as follows:

FINDINGS

The Quileute Tribal Council recently approved a new Quileute Tribal Court schedule and Court dockets. There is good cause to implement the following:

ORDER

1. The court shall schedule three court dates each month. The second court date of each month shall be held via video platform (Zoom and/or other platform as directed by the Court Administrator).
2. Effective January 1, 2023, the court shall set hearings and other court proceedings as follows:

A. Indian Child Welfare and Civil Hearings

- i. Scheduled on the first Tuesday of each month beginning at 11:00 a.m.
- ii. Hearings shall be held in-person at the Quileute Tribal Court.
- iii. Hearing Types: all ICW and other civil matters as directed by the Chief Judge.

B. Criminal, Civil, and Healing-to-Wellness Court Hearings

- i. Scheduled on the second Tuesday of each month beginning at 11:00 a.m.

1 ii. Hearings will be a hybrid of in-person and via video platform. Hearings shall
2 be held in-person for all defendants and Wellness Court participants, and via
3 video platform for Court personnel (*not* including the Court Clerk).

4 iii. Hearing Types: bail review, arraignment, pre-trial (unless a change of plea is
5 anticipated), probation status review, and special set criminal or civil matters.

6 **C. Criminal, Civil, and Healing-to-Wellness Court Hearings**

7 i. Scheduled on the fourth Tuesday of each month beginning at 11:00 a.m.

8 ii. Hearings shall be held in person at the Quileute Tribal Court.

9 iii. Hearing Types: bail review, trial readiness, motion hearing, sentencing,
10 probation status review, warrant quash, protection order petitions, and special set
11 criminal and civil matters.


12 **D. Requests to Appear Via Video Platform**

13 i. The Court may allow a party to appear via video platform on a case-by-case
14 basis. All requests for video appearances must be in writing and filed with the
15 Court at least three days prior to the scheduled hearing. A decision will be made
16 by the Court whether to grant the request for video appearance at least 24 hours
17 prior to the scheduled hearing.

18 ii. All persons who have been granted permission to appear virtually are
19 responsible for providing their correct contact information, including phone
20 number and email address to the Court Clerk *prior to the hearing*. The Court
21 Clerk's office will not be responsible for incomplete or incorrect contact
22 information.

23 3. This Order shall remain in full force and effect until rescinded by the Court.
