

QUILEUTE TRIBE EDUCATIONAL GIFT POLICY AND PROCEDURES

SECTION 1. General Provisions

SECTION 1.1 TITLE

This policy shall be cited in full form as the "Educational Gift Policies and Procedures of the Quileute Tribe" and in short form as the "Educational Gift Policy"

SECTION 1.2 Policy

Subject to available funding and budget limitations, it is the policy of the Quileute Tribe to provide a limited "gift" amount to support successful achievement of educational milestones reached by Tribal members. The "gift" amounts, whether monetary or item related, are subject to change per direction of Quileute Tribal Council.

Section 1.3 PURPOSE

The purpose of this policy shall be to:

- A. Specify the criteria and procedures for qualification of "gift" benefits to Quileute tribal members.
- B. Provide information on what types of educational milestones qualify for these benefits.
- C. Provide information on limitations to accessing benefits set forth in this policy.

Section 1.4 DEFINITIONS

- A. Enrollment Office: The Enrollment Office of the Quileute Tribe where tribal member enrollment information is located.
- B. Tribal Member: An enrolled member of the Quileute Tribe, or non-enrolled infant age two years or younger who is otherwise eligible for enrollment with the Quileute Tribe.

SECTION 2. BENEFITS

SECTION 2.1 ELEGIBILITY

To be eligible to receiver educational gifts a person:

A. Must be an enrolled member of the Quileute Tribe and provide proof of Certificate of Indian Blood. (CIB). CIB can be obtained at Enrollment Office.

SECTION 2.2 BENEFITS AVAILIBLE

- A. Completion of 8th Grade-\$100
- B. High School Graduation- \$500 and a blanket from Council.
- C. GED completion-\$500 and a blanket from council
- D. Completion of advanced education programs above and beyond High School/GED

i)	Under six month vocational	\$200
ii)	Six months to one year approved vocational program	\$500
iii)	Eighteen month approved vocational program	\$600
iv)	Two year approved vocational program	\$600
v)	AA/AAS (two year degree)	\$600
vi)	BA (four year degree)	\$1200

 If graduates of a two-year program continue to complete a four year degree they will receive an additional \$600 to equal the \$1200.00 gifted for completion of a BA Degree

vii) MA (Graduate Degree)	\$2000
viii) Doctorate Degree	\$3000

SECTION 3 REQUIREMENTS AT EACH MILESTONE

SECTION 3.1 COMPLETION OF 8th GRADE

Tribal Member must:

- A. Must bring copy of final report card received after completion of your 8th grade year to the tribal office.
- B. Must complete request for educational gift form, attach to report card and turn in at the front desk of the tribal office.

SECTION 3.2 GRADUATION OF HIGH SCHOOL

- A. Must provide a signed diploma verifying completion of your High School to the tribal office. Graduation announcements or walking with the graduating class will not be accepted as proof of meeting graduation requirements.
- B. Must complete request for educational gift form, attach to report card and turn in at the front desk of the tribal office.

SECTION 3.3 COMPLETION OF GED

- A. Must bring in copy of certified GED certificate.
- B. Must complete request for educational gift form, attach to GED certificate and turn into the front desk of the tribal office.

SECTION 3.4 COMPLETION OF ADVANCED EDUCATIONAL PROGRAM BEYOND HIGH SCHOOL GRADUATION/GED (Vocational Certificates, AA, AAS, BA, MA and Doctorate)

- A. Must provide a signed diploma/certificate verifying completion of your college degree/vocational program to the tribal office. Graduation announcements or walking with the graduating class will not be accepted as proof of degree completion.
- B. Must complete request for educational gift form, attach to official transcript and turn in at the front desk of the tribal office.

NOTE: Funds received from the tribe could be considered taxable income under some circumstances. Please consult with your tax preparer on a case-by-case basis
