Open Fishing Area

Quillayute River from mouth upstream to confluence of Bogachiel and Leyendecker bridge on the Sol Duc River.

Opening /Closing Periods for 4/8/2024 thru 5/1/2024

Opens at 5:00 AM on specified opening days of schedule for each week.
Closes at 5:00 PM on specified closing days of schedule for each week.

Opening /Closing Periods for 5/6/2024 thru 6/25/2024

Opens at 5:00 AM on specified opening days of schedule for each week.
Closes at 5:00 PM on specified closing days of schedule for each week.

Opening /Closing Periods for 7/1/2024 thru 8/27/2024

Opens at 5 AM on specified opening days of schedule for each week.
Closes at 10 AM on specified closing days of schedule for each week.

Gear Restrictions

One net only, set or drift, per boat.

Weeks 15 -18: 7 ^{3/4} inch minimum mesh size (For Steelhead Conservation).

Weeks 32 -35: If Sol Duc stage height falls below 15.30 - 7 ^{3/4}" minimum monofilament mesh, 25ftm max net length, set net only.

Note: These flow initiated restrictions can be activated and lifted within the same statistical week.

Note:

- 1.) Schedule may be modified for conservation or other management purposes.
- 2.) Schedule adjustments and closures will be posted.
- 3.) All other regulations as per Quileute Tribal fishing ordinance 2019-A-40

From Harbor Entrance to the mouth of the Quillayute River both sides, reflective tape or lighted device must be attached to the end of the net closest to the Navigational Channel.
